In consideration of the purchase of scrip by _____, (hereinafter called "Purchaser"), St. Mary of the Immaculate Conception Parish (hereinafter called "Parish") agrees to offer a rebate for purchase of scrip equivalent to 50 per cent (which rebate is no more than 50% of the difference between what the Parish pays for scrip and the face value of the scrip).

Rebate Information:

Purchaser has the complete freedom to determine how the rebate is to be received by choosing one (1) of three options:

- 1. Purchaser will receive the quarterly rebate by means of a check paid by the Parish on a quarterly basis and Purchaser is under no obligation to spend or apply this check in any particular way.
- 2. Purchaser determines that the rebate is to be retained by the Parish for support of the parish elementary school; Purchaser and Parish understand that the Purchaser may be entitled to a charitable deduction under IRS regulations for this amount.
- 3. Purchaser determines that the rebate is to be applied to the tuition obligation of Purchaser or other person designated by Purchaser: _____, Purchaser and Parishioner understand that the Purchaser is not entitled to a charitable deduction under IRS regulations for this amount.

Purchaser is to select the applicable option by **initialing** the box before the option above. If no option is chosen, then option #1 is considered chosen.

This agreement continues in effect until revoked or modified in writing by the Purchaser or until the Parish ends or modifies its scrip or rebate program and notifies Purchaser by placing a notice of such ending or modification in the Parish bulletin.
